Hibaldstow Parish Council Minutes of the Parish Council Meeting

Minutes of the meeting of Hibaldstow Parish Council held at 8.20pm on Thursday 12th April 2012 at the Village Hall, Hibaldstow.

61. Public participation

Mr Carr and Mrs Coxon informed the Council that they had received no feedback from NLC regarding the concerns at 49 West Street. Mr Carr expressed his disappointment with the Ward Cllrs as no update had been received and at the last meeting Cllr England stated that if he were unable to attend this meeting an update would be provided.

Both residents asked for support from the Parish Council. The Clerk stated she would contact NLC and ask for a status report and pass this information to all concerned.

Mr Carr stated the building was unsafe and this should override any legal obligations and the whole site be cordoned off.

64. Minutes of Previous minutes

The minutes of the Parish Council Meeting held on Thursday 8th March 2012 were approved and signed as a true and correct record.

65. Clerk's Report

- a) Clerk has advertised the Annual Parish Meeting in the latest edition of the Village Voice. Noted.
- b) Clerk has asked NLC to look into the white lining on the roads around the village and reminded them of the state of repair to Hibaldstow Bridge road and the condition of Gainsthorpe Road due to activities at the 4x4 centre and the quarry. Clerk to chase.
- c) Notice board doors replaced. It was noted that they look good.

67. Police Matters / NATs Report

Cllr Charlton attended the NATs meeting held at Scawby on 11/04. Hibaldstow crime stats have seen a slight decrease in the area and Street Sports held on the playing field is doing well.

70. Village Hall / Playing Fields

- a) An amended Management Schedule has been received from the Solicitor and a request for a joint meeting with the VHC Solicitor to finalise the Lease. It was resolved that items 3 & 5 of schd2 are removed regarding 24 security and the yearly grant. 6 for with 4 abstentions.
 - Clerk to forward this information to the Solicitor with dates for the Clerk and Cllr Brooks to attend a meeting.
- b) Cllr Stothard informed members that the VHC had held 2 meetings one which discussed the Management Schedule and the other to discuss the refurbishment of the toilets, painting of the Village Halls lobby and toilets due to the lack of attendance no resolutions were made.
 - Cllr Sheppard stated that the tennis courts were dangerous, it was suggested if this was the case they should be cordoned off.

71. Highways

Clerk to report the following issues to NLC:-

- Manton Road sign knocked off the posts (A15 side).
- A15 south carriageway on the railway bridge several large pot holes.
- Left hand bends from Redbourne a large depression in the road which NLC keep filling to no avail.
- Hibaldstow Bridge Road chase for answers.
- Fatality sign near to the roundabout on the A15 hanging off brackets.
- Hunts Lane dog fine sign knocked down.
- Greenfield going into Nookings street sign knocked off.
- Grass cuttings not collected causing blockage in drains.

Cllr Charlton stated that since the issue of the planning approval Gainsthorpe Road is being swept weekly.

72. Cemetery

a) Cllr Brooks and Cllr Stothard met with the grass cutting contractor to discuss the 2012 requirements. NLC had previously told the contractor not to cut the parish cemetery grass and they would do it. This has been rectified and the contractor will cut the closed churchyard and the parish cemetery. Clerk to contact NLC and inform them of the confusion. The new cemetery signage has been removed by persons unknown.

The Working Party will look at the regulations including consultation with others. The Working Party consists of Cllrs Brooks, Hyslop, Stothard & Wragg.

73. Delegates Report

a) Cllr Talliss informed members that there had been 3 meetings but not all meetings had been well attended. The Working Party has come up with ideas for the majority of age groups including children's party and fancy dress, Barber Shop Choir, picnic, bar and some more music. The event to take place on Tuesday 5th June. The 2 members of the public would prepare the food. It is hoped the event will be free. **It was resolved that** the Parish Council allocated £1,125 to the cost of the celebrations.

Friends of Hibaldstow School were asked to join in with the organisation of the celebrations along with the Village Hall Committee - both declined and the Village Hall Committee would not donate to the event.

Cllr Wragg stated the medals will be ready for collection in 10 days. Cllr Wragg also expressed disappointment that the VHC had not donated any funds, when he was a member of the Fete Committee the money raised at the Fete should be used for a community activity and this event would have been ideal to donate some of those funds.

- Cllr Brooks asked if this had been voted on Cllr Sheppard said it had not been voted on but an agreement at the meeting.
- b) Cllr Brooks informed the meeting that the School was now Academy status and will be called St Hybald's Academy and would cover the federation schools.

3 Trustees had been appointed and the 30 Governors that had been serving were now down to the Academy requirement of 15.

Interviews were taking place to appoint a Deputy Head. Cllr Brooks was no longer serving as a Governor. It was agreed to send a letter of congratulations to the school moving on from special measures to its status now. Cllr Brooks was also thanked for his contributions.
